Minutes of the 2020 IETM General Assembly

As physical events could not take place and in accordance with Belgian law, the IETM 2020 General Assembly was held via written procedure.

All the members who had paid their membership fee received documentation and a voting template form on 10 July 2020, as well as instructions on how to proceed. Taking into consideration the European Summer holidays period, members had until 1 September 2020 to return their vote.

The results and minutes of the IETM General Assembly 2020 were sent out to members on 7 September 2020 as follows:

The IETM Board of Directors is pleased to announce that the IETM General Assembly 2020, conducted via a written procedure, is now complete.

In total, 116 votes were received from members by the deadline of 23:59 CEST on 1 September 2020, exceeding by far the 10% quorum required by the statutes of IETM.

Out of the 116 votes received, six were invalid: four were declared ineligible for having been incorrectly completed and two were sent by members who had not paid their 2020 membership fee.

Out of the 110 valid votes received, the six propositions sent out were adopted and agreed by IETM members as follows:
